

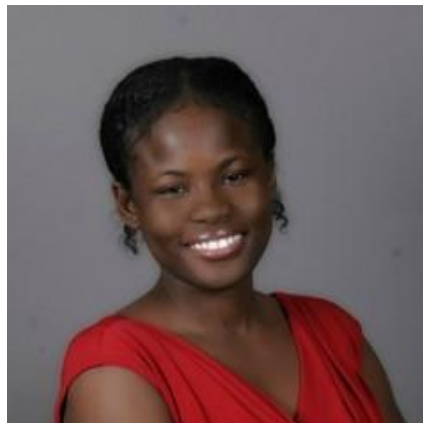
**Panel Theme - Integrating the United Nations Sustainable Development Goals in Corporate Social Responsibility: Comparative Perspectives & Policy Options**
